- Milad-un-Nabi, Id-ul-Fitr, Id-ul-Zuha (Bakrid) and Muharram which fall on Wednesday, the 16th February, Wednesday, the 31st August, Monday, the 7th November and Tuesday, the 6th December respectively are subject to change depending upon the visibility of the moon.
- During the Christmas Holidays, the Registry will remain closed from 26th December, 2011 to 31st December, 2011 (Both days inclusive).
